- The WSJ poll also found: "By 10 points, more voters have a favorable than unfavorable view of Trump's economic plan for the country, while unfavorable views of Harris's economic plan outweigh positive views by 4 points."

Immigration Reform

- Border Czar Kamala Harris has failed to secure the border.
- 10.4 million illegal immigrants have crossed the southern border since Harris & Biden took office.
- This includes the 8.4 million illegal immigrants that Customs and Border Protection (CBP)
 has encountered and the roughly 2 million gotaways that have escaped past Border Patrol
 into the U.S.
- 101,790 illegal immigrants were encountered attempting to cross the U.S.-Mexico border in September.
- That's a 112% increase from the average number of September apprehensions during the Trump administration.
- This number does not include the administration's funneling of illegal immigrants through the CBP One App which also processed 44,600 migrants in September alone.
- 6,524 unaccompanied children were encountered.
- 49,269 illegal immigrants were encountered from countries outside the Northern Triangle and Mexico, showing that Biden's crisis is global.
- At least 103 people on the terror watchlist have been encountered trying to enter the U.S. between ports of entry this fiscal year.
- This is in sharp contrast to President Trump's term, when only 14 people on the terror watchlist were encountered total.
- Drugs are pouring over the border and into our communities.
- Illicit drugs are flowing into the country at an alarming rate, with only 5 to 10% being intercepted as border officials struggle to contain the smuggling.
- 2,169 pounds of deadly fentanyl and 6,984 pounds of methamphetamine were seized at the southern border in September alone, with much more getting through.
